

## KISW Terms of Service

---

### 1. ACCEPTANCE OF TERMS

Entercom Seattle, LLC d/b/a KISW ("KISW") welcomes you to the KISW Rock Girl Calendar website ("Site"). KISW provides this service to you subject to the following Terms of Service ("TOS"), which may be updated by us from time to time with or without notice to you. You can review the most current version of the TOS at any time at: <http://www.kiswrockgirlcalendar.com>. In addition, when using particular services made available to you on the Site, you shall be subject to any posted guidelines or rules applicable to such services, which may be posted from time to time. All such guidelines or rules are hereby incorporated by reference into the TOS. KISW may also offer other services that are governed by different Terms of Service.

### DESCRIPTION OF SERVICE

KISW will provide users of the Site with access to a variety of resources from time to time, including various communications tools, calendar service, search services, and personalized content which may be accessed through any various medium or device now known or hereafter developed (the "Service"). You also understand and agree that the Service may include advertisements and that these advertisements are necessary for KISW to provide the Service. You also understand and agree that the Service may include certain communications from KISW, such as service announcements, administrative messages and the KISW Newsletter, and that these communications are considered part of KISW membership and you may not be able to opt out of receiving them. Unless explicitly stated otherwise, any new features that augment or enhance the current Service in the future shall be subject to the TOS. You understand and agree that the Service is provided "AS-IS" and that KISW assumes no responsibility for the timeliness, deletion, mis-delivery or failure to store any user communications or personalization settings. You are responsible for obtaining access to the Service, and that access may involve third-party fees (such as Internet service provider or airtime charges). You are responsible for those fees, including those fees associated with the display or delivery of advertisements. In addition, you must provide and are responsible for all equipment necessary to access the Service.

### 2. YOUR REGISTRATION OBLIGATIONS

In consideration of your use of the Service, you represent that you are of legal age to form a binding contract and are not a person barred from receiving services under the laws of the United States or other applicable jurisdiction. You also agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the Service's registration form (the "Registration Data") and (b) maintain and promptly update the Registration Data to keep it true, accurate, current and complete. KISW is concerned about the safety and privacy of all its users, particularly children. **For this reason, parents of children under the age of 13 who wish to allow their children access to the Service must create a KISW Guardian Account.** When you create a KISW Guardian Account and add your child to the account, you certify that you are at least 18 years old and that you are the legal guardian of the child/children listed on the KISW Guardian Account. You understand that through your use of the Service you consent to the collection and use (as set forth in the Privacy Policy) of this information, including the transfer of this information to the United States and/or other countries for storage, processing and use by KISW and/or its affiliates, advertisers and vendors.

### 4. MEMBER ACCOUNT, PASSWORD AND SECURITY

You will receive a password and account designation upon completing the Service's registration process. You are responsible for maintaining the confidentiality of the password and account and are fully responsible for all activities that occur under your password or account. You agree to (a) immediately notify KISW of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you exit from your account at the end of each session. KISW cannot and will not be liable for any loss or damage arising from your failure to comply with this Section 4.

### 5. MEMBER CONDUCT

You understand that all information, data, text, software, music, sound, photographs, graphics, video, messages, tags, or other materials ("Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from whom such Content originated (except as otherwise expressly set forth in this TOS). This means that you, and not KISW, are entirely responsible for all Content that you upload, post, email, transmit or otherwise make available via the Service. KISW does not control the Content posted via the Service and, as such, does not guarantee the accuracy, integrity or quality of such Content. You understand that by using the Service, you may be exposed to Content that you may find offensive or

objectionable. Under no circumstances will KISW be liable in any way for any Content, including, but not limited to, any errors or omissions in any Content, or any loss or damage of any kind incurred as a result of the use of any Content posted, emailed, transmitted or otherwise made available via the Service, whether posted by KISW or any third party.

You agree to not use the Service to:

- h. upload, post, email, transmit or otherwise make available any material that contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer software or hardware or telecommunications equipment;
- i. disrupt the normal flow of dialogue, cause a screen to "scroll" faster than other users of the Service are able to type, or otherwise act in a manner that negatively affects other users' ability to engage in real time exchanges;
- j. interfere with or disrupt the Service or servers or networks connected to the Service, or disobey any requirements, procedures, policies or regulations of networks connected to the Service;
- k. intentionally or unintentionally violate any applicable local, state, national or international law, including, but not limited to, regulations promulgated by the U.S. Securities and Exchange Commission, any rules of any national or other securities exchange, including, without limitation, the New York Stock Exchange, the American Stock Exchange or the NASDAQ, and any regulations having the force of law;

- i. provide material support or resources (or to conceal or disguise the nature, location, source, or ownership of material support or resources) to any organization(s) designated by the United States government as a foreign terrorist organization pursuant to section 219 of the Immigration and Nationality Act;
- m. "stalk" or otherwise harass another; and/or
- n. collect or store personal data about other users in connection with the prohibited conduct and activities set forth in paragraphs a through m above.

You acknowledge that KISW may or may not pre-screen Content, but that KISW and its designees shall have the right (but not the obligation) in their sole discretion to pre-screen, refuse, or remove any Content that is available via the Service. Without limiting the foregoing, KISW and its designees shall have the right to remove any Content that violates the TOS or is otherwise objectionable in KISW's sole discretion. You agree that you must evaluate, and bear all risks associated with, the use of any Content, including any reliance on the accuracy, completeness, or usefulness of such Content. In this regard, you acknowledge that you may not rely on any Content created by KISW or submitted to KISW and available on or through the Site, including without limitation information in any KISW Message Boards and in all other parts of the Service.

You may not attempt to override or circumvent any of the usage rules embedded into the Service. ## 6. INTERSTATE NATURE OF COMMUNICATIONS ON KISW NETWORK

When you register with KISW, you acknowledge that in using KISW services to send electronic communications (including but not limited to email, search queries, sending

messages to KISW, uploading photos and files to the Site, and other Internet activities), you will be causing communications to be sent through KISW's computer networks, portions of which are located in one or more locations in the United States and portions of which may be located abroad. As a result, and also as a result of KISW's network architecture and business practices and the nature of electronic communications, even communications that seem to be intrastate in nature can result in the transmission of interstate communications regardless of where you are physically located at the time of transmission. Accordingly, by agreeing to this Terms of Service, you acknowledge that use of the Service results in interstate data transmissions.

#### 7. SPECIAL ADMONITIONS FOR INTERNATIONAL USE

Recognizing the global nature of the Internet, you agree to comply with all local rules regarding online conduct and acceptable Content. Specifically, you agree to comply with all applicable laws regarding the transmission of technical data exported from the United States or the country in which you reside.

#### 8. CONTENT SUBMITTED OR MADE AVAILABLE FOR INCLUSION ON THE SERVICE

KISW does not claim ownership of Content you submit or make available for inclusion on the Service. However, with respect to Content you submit or make available for inclusion on publicly accessible areas of the Service (if any), you grant KISW the following worldwide, royalty-free and non-exclusive license(s), as applicable:

- a. With respect to Content you submit or make available for inclusion on publicly accessible areas of KISW Groups, the license to use, distribute, reproduce, modify, adapt, publicly perform and publicly display such Content on the Service solely for the purposes of providing and promoting the specific KISW Group to which such Content was submitted or made available. This license exists only for as long as you elect to continue to include such Content on the Service and will terminate at the time you remove or KISW removes such Content from the Service.
- b. With respect to photos, graphics, audio or video you submit or make available for inclusion on publicly accessible areas of the Service other than KISW Groups, the license to use, distribute, reproduce, modify, adapt, publicly perform and publicly display such Content on the Service solely for the purpose for which such Content was submitted or made available. #### 10. INDEMNITY

You agree to indemnify and hold KISW and its subsidiaries, affiliates, officers, agents, employees, partners and licensors harmless from any claim or demand, including reasonable attorneys' fees, made by any third party due to or arising out of Content you submit, post, transmit or otherwise make available through the Service, your use of the Service, your connection to the Service, your violation of the TOS, or your violation of any rights of another.

#### 11. NO RESALE OF SERVICE

You agree not to reproduce, duplicate, copy, sell, trade, resell or exploit for any commercial purposes, any portion of the Service (including your KISW ID), use of the Service, or access to the Service.

#### 12. GENERAL PRACTICES REGARDING USE AND STORAGE

You acknowledge that KISW may establish general practices and limits concerning use of the Service, including without limitation the maximum number of days that email messages, message board postings or other uploaded Content will be retained by the Service, the maximum number of email messages that may be sent from or

received by an account on the Service, the maximum size of any email message that may be sent from or received by an account on the Service, the maximum disk space that will be allotted on KISW's servers on your behalf, and the maximum number of times (and the maximum duration for which) you may access the Service in a given period of time. You agree that KISW has no responsibility or liability for the deletion or failure to store any messages and other communications or other Content maintained or transmitted by the Service. ### 14. TERMINATION

You agree that KISW may, *without prior notice and with or without cause*, immediately terminate your KISW account, any associated email address, and access to the Service. Cause for such termination shall include, but not be limited to, (a) breaches or violations of the TOS or other incorporated agreements or guidelines, (b) requests by law enforcement or other government agencies, (c) a request by you (self-initiated account deletions), (d) discontinuance or material modification to the Service (or any part thereof), (e) unexpected technical or security issues or problems, (f) extended periods of inactivity, (g) engagement by you in fraudulent or illegal activities, and/or (h) nonpayment of any fees owed by you in connection with the Services. You further acknowledge and agree that Content contained in sponsor advertisements or information presented to you through the Service or by advertisers is protected by copyrights, trademarks, service marks, patents or other proprietary rights and laws. Except as expressly permitted by applicable law or authorized by KISW or advertisers, you agree not to modify, rent, lease, loan, sell, distribute or create derivative works based on the Site, Service or the Software, in whole or in part.

KISW grants you a personal, non-transferable and non-exclusive right and license to use the object code of its Software on a single computer; provided that you do not (and do not allow any third party to) copy, modify, create a derivative work from, reverse engineer, reverse assemble or otherwise attempt to discover any source code, sell, assign, sublicense, grant a security interest in or otherwise transfer any right in the Software. Without KISW's prior permission, you agree not to display or use in any manner the KISW Marks nor that of any of the Site's advertisers.

#### 24. NOTICE AND PROCEDURE FOR MAKING CLAIMS OF COPYRIGHT OR INTELLECTUAL PROPERTY INFRINGEMENT

KISW respects the intellectual property of others, and we ask our users to do the same. KISW may, in appropriate circumstances and at its discretion, disable and/or terminate the accounts of users who may be repeat infringers.
